The restricted stock issued to the reporting person is based on the \$18.61 closing price of the common stock on June 5, 2018, as quoted on the NASDAQ Global Select Market. The restricted stock vests in four equal installments on September 5, 2018, December 5, 2018, March 5, 2019 and June 5, 2019.
